At the request of our donors, World Impact developed *Direct IMPACT*, a voluntary program that allows you to give electronically in one of two ways:

1. **Electronic Funds Transfer (EFT)**— Allows World Impact to electronically transfer your donation directly from your bank account to World Impact’s bank account.
2. **Credit Card**— Allows World Impact to directly charge your Visa or MasterCard account.

Benefits

1. You save time by not writing checks.
2. You save postage and check costs.
3. Your monthly support will not be delayed or lost in the mail.
4. You do not have to remember to give while on vacation.
5. The amount you give can be changed or canceled at any time by notifying World Impact *in writing*.
6. World Impact will process your gifts more efficiently, allowing us to be better stewards.
